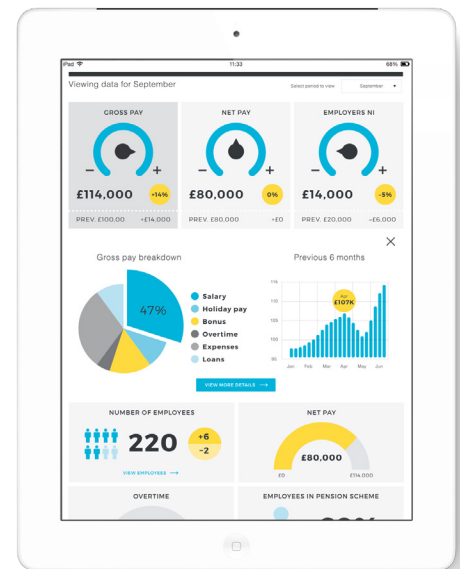
- All data is stored on Microsoft Azure servers located within the EU

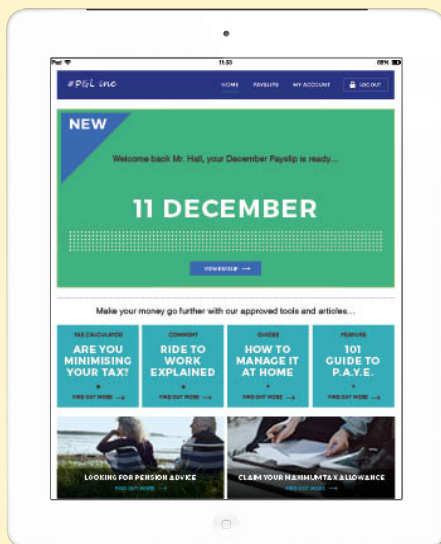
